 (2) Titagarh Capital Management Services Private Limited (PAN: AACCT5853F) (TCMSPL) has acquired 134,722 and 111,777 equity shares of Titagarh Wagons Limited (the Company) on 30th March, 2022 and 31st March, 2022 respectively through market purchase from public category shareholder(s). However, the said shares were not credited into TCMSPL's demat account till 31st March, 2022, and also did not appear in the BENPOS of the Company as at 31st March, 2022 from the Depositories and furnished by the Company's Registrar. Therefore, the aforesaid 246,499 shares (representing 0.21% of the Company's paid-up share capital) could not be taken as held by TCMSPL in the shareholding pattern as on 31st March, 2022.
